Derbyniwyd y newydd diweddaraf wrth y clerc am sefyllfa iechyd y clerc newydd Mr Owen Enoch a dywedodd ei fod yn gobeithio bod yng nghyfarfod Mis Mawrth y Cyngor ./ The clerk gave a brief update on the new clerk Mr Owen Enoch health circumstances and informed that he hoped to be in attendance at the Councils March meeting

Cynigiodd , y Cyng Wyn Evans ac eiliwyd gan, Cyng J Howells a cytunodd pob aelod fod cofnodion Mis Ionawr yn gywir. /

It was proposed by Cllr Wyn Evans and seconded by Cllr J Howells and all members agreed that the minutes of the January meeting were correct.

5.0 Materion yn Codi o'r cyfarfod diwethaf / Matters arising from the previous meeting .

a. Yn y cyfarfod diwethaf derbyniwyd gwybodaeth wrth y Cyng Vilna Thomas bod rhan o olau'r stryd ar y rhiw rhwng Porthyrhyd a Llanddarog ddim yn gweithio yn ystod y nos. Roedd y clerc wedi ysgrifennu at y Cyngor Sir nifer o weithiau ond roedd y golau heb ei atgyweiro . / At the previous meeting Cllr Vilna Thomas informed that the lights on the hill from Porthyrhyd to Llanddarog were not lit at night . She was aware that the clerk had written several times to CCC to request that they look at the issue and take the appropriate action but to date no work had been undertaken.

Derbyniwyd yr e bost canlynol wrth CCC./ The following reply was received from CCC by e mail

“One of the electricians called on site this morning to see if he could find out why the lights are coming off & on at various times & why they come on when tested but go off when needed.

The feeder pillar on the opposite side of the road has been damaged (possibly by a hedge cutter) , there is a hole in the roof of a control box & everything inside is soaking wet, the circuit is breaking down under load, so this explains why they are going out in the evening when there is a demand for energy. We have placed an order with one of our contractors to replace the feeder pillar & provide a new cut out, once this work has been completed the lights should be back to normal. Please let me know if you need further information, we have asked for this work to be carried out asap so please let me know if by middle of next week if the fault remains the same.”

d. Danfonwyd gwybodaeth at y Cyngor Sir bod y Cyngor wedi ail benodi y Cyng Terry Jones fel ei cynrychiolydd ar Gorff Llywodraethol Ysgol Gynradd Llanddarog / The County Council were informed that the Council had decided to re appoint Cllr Terry Jones as their representative on the Governing Body of Llanddarog Primary School

Ar ol trafodaeth penderfynodd y Cyngor rhoi help ariannol o £200 / After a discussion the council agreed to give a financial assistance of £200.
