Mynychodd aelod o'r cyhoedd cyfarfod Cyngor Cymuned Llanddarog ar 11/03/2020 a penderfynwyd cynnal cyfarfod anarferol i drafod pryderon y gymuned ynghylch y CDLI newydd yn Porthyrhyd. Sylwyd bod safle posib wedi ail-ymddangos ar y cynllun - (SuV20 / h1) Fferm Llwyn Henri. Yn flaenorol, roedd y safle wedi'i glustnodi a'i wrthod oherwydd diogelwch a lles yr ardal gyfagos. Penderfynwyd i'r clerch ymchwilio ac adrodd ar ei ganfyddiadau i'r cyngor er mwyn rhoi cais gwrthwynebiad i'r Cyngor Sir cyn y dyddiad cau o Ddydd Gwener 27/03/2020.

Mae wedi darganfod adroddiad o 2012 a munudau cyfarfodydd Cyngor Cymuned Llanddarog yn trafod y safle a rhesymau ynghlwm a pham roedd y safle wedi cael ei wrthod.

Awgrymwyd rhoi cais am wrthwynebiad i Gyngor Sir Caerfyrddin cyn gynted a bosib gan Cyng J Williams O.B.E. a cafodd ei eilio gan y Cyng S Herridge.

Penderfynwyd bod angen 2 gynghorydd I fynychu unrhyw gyfarfod ynghlyn ar safle a dewisiwyd Cyng J Williams O.B.E ar Cyng S Herridge.

A member of the public attended the Llanddarog Community Council meeting on 11/03/2020 and it was agreed to hold an extraordinary meeting to discuss community concerns regarding the new LDP in Porthyrhyd. It was noted that a potential site had re-appeared on the plan - (SuV20 / h1) Llwyn Henri Farm. The site had previously been allocated and refused due to the safety and welfare of the surrounding area. It was resolved that the clerk to investigate and report his findings to the council in order to submit an objection request to the County Council before the closing date of Friday 27/03/2020.

He has discovered a report from 2012 and minutes of Llanddarog Community Council meetings discussing the site and reasons why the site had been rejected. It was suggested by Cllr J Williams O.B.E and seconded by Cllr S Herridge that an application for objection be made to Carmarthenshire County Council as soon as

possible. It was decided that 2 councilors were required to attend any site meeting and Cllr J Williams O.B.E and Cllr S Herridge were selected.
